Environmental Services Administrator Josh Johnson addressed the Board and received approval on the following resolutions:

RESOLUTION 11-21-03

Conditional Use Permit for Don & Marilyn Mathsen to construct a wet flood proofed addition to a previously constructed building in the 1% floodplain of Marshall County.

WHEREAS, Marshall County Floodplain Ordinance, Section 5.41 requires a Conditional Use Permit to utilize alternative elevation methods other than the use of fill to elevate a structure's lowest floor above the regulatory flood protection elevation.

WHEREAS, Don & Marilyn Mathsen plan meets all requirements of the Marshall County Floodplain Ordinance; and

WHEREAS, The Marshall County Board of Commissioners find:

- 1. The property is 11.6 acres.
- 2. The entire property is located in the 1% floodplain.

- 3. The proposed addition is 22'x 26' (572 sq. ft.) with a max height of 28'.
- 4. The addition would contain a garage on the lower level and a bedroom and office on the upper level.
- 5. The lowest elevation on the dike surrounding the property is 813.07'. The base flood elevation is 811' The concreate floor is proposed to be 808' with the structure being wet flood proofed to an elevation of 812.5'.
- 6. All construction materials will meet the required flood proof construction requirements of the ordinance.
- 7. The applicants use the property seasonally. The maintain the property for recreation, gardening, and family gatherings.
- 8. The existing structure building contains a kitchen, bathroom, and living space
- 9. The proposed use is a conditional use expressly designated in the ordinance.
- 10. The conditional use will not be injurious to the use and enjoyment of other property in the immediate vicinity for the purposes already permitted, nor substantially diminish or impair property values within the immediate vicinity.
- 11. The establishment of the conditional use will not impede the normal and orderly development and improvement of surrounding vacant property for uses predominant in the area.
- 12. Adequate utilities, access roads, drainage and other necessary facilities have been or are being provided.

NOW THEREFORE BE IT RESOLVED, That the Marshall County Board of Commissioners grant a conditional use permit to Don & Marilyn Mathsen_to construct a wet flood proofed addition to a previously constructed building in the 1% floodplain of Marshall County with the following conditions:

- 1. Submit as-built certification by a registered professional engineer or architect that the structure was flood proofed in accordance to FP-3/FP-4 building/floodproofing specifications authorized in Section 4.45c of the Marshall County Floodplain Management Ordinance.
- 2. The lowest floor in the structure will not be used for habitable space such as living, sleeping, eating, or cooking.
- 3. Hazardous materials stored in the structure must be labeled and stored above the regulatory flood protection elevation of 812 feet.
- 4. Elevate all electrical equipment, circuits, and installed electrical appliances above the regulatory flood protection elevation.
- 5. Install a minimum of two automatic openings in the addition sized according to rate of rise of flood waters.

WHEREAS, The Marshall County Board of Commissioners has reviewed the aforementioned Marshall County Buffer Ordinance; and

WHEREAS, The Marshall County Board of Commissioners has received public comment on the aforementioned Marshall County Buffer Ordinance at the Planning Commission meeting held on November 16, 2017.

NOW THEREFORE BE IT RESOLVED, That the Marshall County Board of Commissioners hereby adopts the 2017 Marshall County Buffer Ordinance; and

BE IT FURTHER RESOLVED, that the Marshall County Board of Commissioners hereby submits the 2017 Marshall County Buffer Ordinance to the Minnesota Board of Water and Soils Resources for final approval pursuant to applicable Minnesota Statues and Rules. **M/S/C - Kiesow, Vonasek (3,0)**
